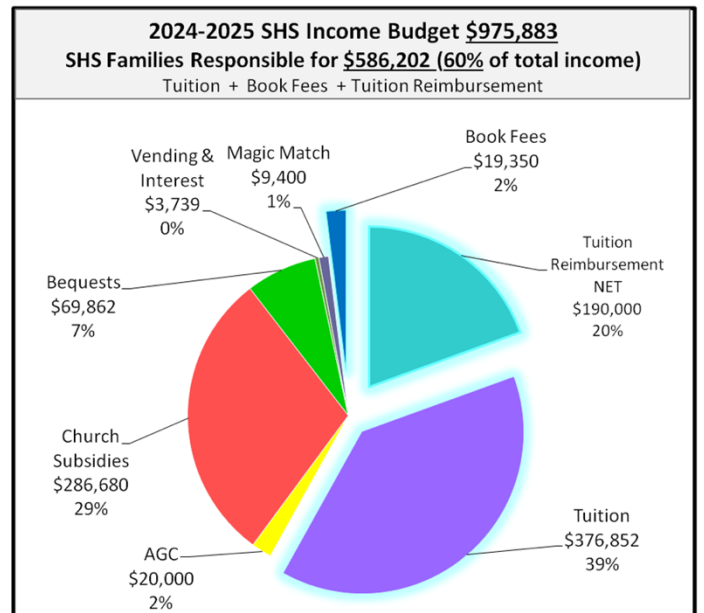
SHS families are expected to bring in \$586,202 or 60% of the cost to run the school for the 2024-2025 school year. This is broken down into three categories: Tuition, Book Fees & Tuition Reimbursement.

Tuition Income is budgeted at \$376,852 or 39% of the cost to run SHS. Book Fees will bring in \$19,350, which is 2% of total income.

The Tuition Reimbursement Contract outlines each school family's commitment towards Tuition Reimbursement Net Income, which is expected to bring in \$190,000 (20% of total income).

The remaining 40% (\$389,681) needed to fund our school is covered by generous donations made by:

- St. Patrick's Church in Pana
- Sacred Heart Church in Oconee
- Businesses
- Individuals / Alumni
- And others who are passionate about supporting Catholic Education.

- 2 children **\$5,692/year** or \$569.20/month* ***\$6,518 minus parishioner discount - \$826**
- 3+ children **\$7,115/year** or \$711.50/month* ***\$8,226 minus parishioner discount - \$1,111**

Non-Parishioner families:

- 1 child **\$4,734/year** or \$473.40/month
- 2 children **\$6,518/year** or \$651.80/month
- 3+ children **\$8,226/year** or \$822.60/month

MULTIPLE CHILD DISCOUNT:

The multiple child discount applies only for children all of whom reside at the same primary residence and who are related to each other by at least ONE of the following criteria:

- a.) Direct genetic relationship - being children of the same father and mother.
- b.) Relationship by legal adoption - the child’s father and/or mother legally adopted the sibling(s).
- c.) Relationship by virtue of current marriage of their parents - marriage being as defined by the Catholic Church.

*** Final determination of the Multiple Child Discount is made by church and school officials. Any legal documentation regarding family status (i.e. separation, divorce) will not be used for consideration for the discount as it is not the business of St. Patrick’s Church of Pana, Sacred Heart Church of Oconee, nor Sacred Heart School of Pana.*

ACTIVE PARISHIONER RATE:

Active parishioner is defined as being involved in weekend mass as a family on a regular basis AND using church envelopes.

Non-active parishioner is defined as attending mass a couple times a year.

Parishioner status will be evaluated in November, March, and August of each year. To remain in good standing, you must:

- a.) Attend Mass as a family each week. We understand that there are circumstances that arise (i.e. sickness, death, vacation), but the 3rd Commandment requires us to attend Mass regularly.
- b.) Participate in Mass.
- c.) Donate to church when possible and mark your envelope “I will pray for my parish.”

*** Due to past families receiving Active Parishioner Rates and not following the requirements as listed above in this CONTRACT, attendance will be monitored via security cameras and church officials. If your Active Parishioner requirements are not met, your tuition will be adjusted to the non-parishioner rate and paid through ACH. If an adjustment in tuition is made and not paid, 4th Quarter Report Cards will be held, and Graduation ceremonies will not take place for each student of the family. Any family failing to uphold this contract will be contacted by Father or a church official for further action.*

I/we understand that all families with children enrolled at Sacred Heart School are expected to participate in fundraisers that support Sacred Heart Organization of Parents (SHOP). SHOP financially supports many activities for the students throughout the year. My/our family is committed to participate in said fundraisers that support SHOP.

If applicable - I/we understand that the tuition rate will be adjusted if I/we fail to meet Active Parishioner Rate requirements and I/we agree to pay the difference. I/we understand that I/we will be in default if I fail to make any type of payment herein. In the event of a default, I agree to pay all reasonable attorney fees and costs of collection to obtain payment pursuant to this agreement.
